## Provision for Entering School and for Proceeding to the Next Level Education [入学・進学支度金の支給]

The town will provide a subsidy for single parent households that their children will enter schools and proceed to the next level of education in this fiscal year.

■ Eligible Persons: Those who became a single parent household or are rearing a child who do not have parents, and who meet all of the following conditions.

- You live in the town and are rearing a child who lives with you.
- Your income tax was not levied against your income of 2019.
- You are not receiving public assistance.

■ Subsidy:

- For primary school: ¥10,000
- For junior high school: ¥15,000
- For high school: ¥20,000

■ Application Method: Fill out necessary contents into the application form, and apply it with required documents directly to the Children Affairs Division (the 23rd counter on the 3rd floor).

■ Deadline of Application: May 28th (Fri.) except Saturdays, Sundays, and National Holidays.

## Rabies Vaccination in Spring [春の狂犬病予防注射]

Spring Rabies Vaccinations (group shots) for FY2021 will be administered by the town. According to the Rabies Prevention Law, those who own a dog (including small dogs and indoor dogs) that is 91days old and older are required to register the dog and have it receive a rabies shot once a year.

■ Registration: Once in a dog's lifetime

■ Frequency of Rabies Vaccination: Once a Year

■ Date, Time, and Location: May 13th (Thu.), 14th (Fri.), 15th (Sat.)

For detail time and locations, please inquire of the Environmental Development Division.

※ Animal hospitals belonging to Gunma Veterinary Medical Association are also available for the registration and the vaccination.

■ Fee: ¥3,500 per registered dog for the vaccination only.

¥6,500 per dog for the registration and the vaccination

※ Please be sure to notify the Environmental Development Division (the 5th counter on the 1st floor in the town hall) of any changes in the registration information such as the death of your dog or a change in the owner.

### < Clean up dog's droppings! >

Many people are annoyed by dog's owners who were leaving droppings on riverbeds, sidewalks, rice paddy roads, and etc.

You, the owner, must clean up your dog's droppings when you walk your dog. Dog waste should be buried in your yard or disposed of as "Burnable Trash" in small amounts in plastic bags to prevent the contents from flying around.

## Notification about Municipal Taxes [税に関するお知らせ]

Municipal taxes are divided into ordinary taxes and earmarked taxes. The ordinary taxes are used for a variety of projects, and the earmarked taxes are used for special purposes.

### [Ordinary Taxes]

#### Resident Tax (Individual):

- Individuals who reside in the town as of Jan. 1st of the relevant year and have income in the previous year are taxed.
- Individuals who have a office, a business establishment, and real estate in the town as of Jan. 1st of the relevant year even though they do not live in the town are also taxed.

**Resident Tax (Corporate):** Corporations that have a office, a business establishment, a dormitory, and etc. are taxed.

**Property Tax:** Those who own property in the town as of Jan. 1st of the relevant year are taxed.

**Light Vehicle Tax:** Those who own light motor vehicles and etc. as of Apr. 1st of the relevant year are taxed.

**Tobacco Tax:** This tax is included in the price of tobaccos.



### [Earmarked Taxes]

**City Planning Tax:** This tax is used for the city planning projects such as roads, sewers, parks, and so on, and is levied on owners of land and houses located in urbanized areas as of Jan. 1st of the relevant year.

**National Health Insurance Tax:** This is a tax that people support each other so that people can receive medical treatments without anxiety. Heads of household with an insured persons are taxed.

#### ■ FY2021(Reiwa-3) Oizumi Town Municipal Taxes Payment Due Date

The payment due date of the Oizumi Town municipal taxes for FY2021 is shown on the right.

Bank transfer is a convenient way to pay your tax. If you wish, please apply for it to the Taxation Division, the Tax Collection Division, (the 9th & 10th counter on the 1st floor in the town hall) or banks directly.

#### ■ The Tax Notice of the Light Vehicle Tax will be sent.

The tax notice of the light vehicle tax will be sent around early May to those who own light motor vehicles and etc. as of April 1st.

Due Date of the payment: May 31st (Mon.)

Payment Methods: You can pay the tax at financial institutions listed on the notice, convenience stores, smartphone apps, and the Tax Collection Division at the 9th counter on the 1st floor in the town hall.

#### < Reduction and Exemption System for the Disabled >

If light motor vehicles owned by a physically disabled person meet certain conditions, the light vehicle tax on the vehicle will be exempted by application. Since application every year is required, please apply for it by May 31st (Mon.) after receiving the tax notice.

### Postponement of tax collection

Postponement system of collection of municipal taxes is available for those who have difficulty paying the municipal taxes due to COVID-19. Please consult with the Tax Collection Division (the 9th counter on the 1st floor in the town hall), if;

- Equipment, fixtures, inventories, or etc. were scrapped due to disinfecting the facility where the patient of COVID-19 occurred.
- The taxpayer or his/her family member who share the same livelihood was infected with COVID-19.
- The business operated by the taxpayer was unwillingly closed.
- There was significant loss due to profit decrease on the business operated by the taxpayer.

In addition, there is a system for postponement of redemption upon application. Please contact the Tax Collection Division if necessary.

## Motor Vehicle Tax (Category Base) is due on May 31st. [5月は自動車税(種別割)の納期です]

The Motor Vehicle Tax (Category Base) is levied on owners of automobiles registered at the transport bureau as of April 1st. The tax notice will be sent around early May from the automobile tax office. So please pay the tax by the due date.

■ Due Date: May 31st, 2021 (Mon.)

■ How to pay:

You can pay the tax by using the tax notice at banks in the prefecture, post-offices, automobile tax offices, the *Gyosei-Kenzei Jimusho*, convenience stores, internet banking, ATM corresponding to "Pay-easy",

You can pay the tax by credit cards via the web-site "Yahoo! *Kokin-Shiharai*", or you can also use the smartphone apps (LINE Pay & PayPay) to pay the tax.

## ■ Antibody Test and Vaccination against Rubella for Males

The town is conducting the antibody test and the vaccination against Rubella for males who were born between 4/2/1962 and 4/1/1979 from 2019 for 3 years. If you have the "coupon ticket" for them which has already been sent to the eligible persons, please receive the antibody test first. If the test result shows that your antibody is not enough, please receive the vaccination.

- How to receive: Please bring the "coupon ticket" to the medical checkup place at your work place, the Town's specific medical check-up, or medical institutions participating in this project, and receive the test and the vaccination.
- Fee: Free of charge

※ The validity of the "Coupon Tickets" issued in FY2019 for males who were born between 4/2/1972 and 4/1/1979 has been extended until the end of March, 2022. If you have lost your "Coupon Ticket", please come to the Health Promotion Division with your identification documents to have it reissued.

## ■ Subsidy for purchasing medical wigs and chest prosthetic devices

The town subsidizes the purchase of medical wigs and chest prosthetic devices for cancer patients.

- Eligible Persons: Cancer patients who meet all of the following condition.  
Those who purchased the above equipment to cover the change in appearance due to cancer treatment.  
Those who are registered as a resident in Oizumi at the time of application and have not failed to pay the municipal taxes.  
Those who have not received the same kind of subsidy from other municipalities in the past.
- Subsidy: Each person can apply once for each ① and ②.  
① Up to ¥30,000 for wigs (wig & net)  
② Up to ¥20,000 for chest prosthetic devices (brassieres, pads, artificial breast)
- Application Method and Deadline: Please inquire of the Health Promotion Division.

## ■ Subsidy for the Comprehensive Medical Examination

The town subsidizes a part of the expense for the Comprehensive Medical Examination.

- Eligible Persons: Those who are enrolled in the National Health Insurance and also whose households pay the National Health Insurance tax in full, and residents in the town who are enrolled in the Gunma Prefecture Long-Life Medical Care System and also pay the Long Life Medical Care Premium in full.
- Application Method: Please apply to the National Health Insurance Division (the 2nd counter on the 1st floor in the town hall) directly with necessary documents after receiving the Comprehensive Medical Examination.  
※ Please apply for the medical examination by yourself.
- Subsidy: 60% of an expense for the comprehensive medical examination will be subsidized with the following limitation.  
For the one day medical examination: ¥20,000  
For the overnight medical examination: ¥30,000  
For the brain medical examination: ¥30,000
