Applying for "*Gakudo Hoiku* (After-School Care Program)" for FY2022 [令和4年度学童保育児童を募集します]

The town will look for children who wish to join the "Gakudo Hoiku (After-School Care Program)" from April, 2022. If your child is currently enrolled in the "Gakudo Hoiku", you will also need to complete the necessary procedures, so please do not forget to apply. In addition, if you would like to use it only during long holidays or in the middle of the school year, please apply at that time. When applying for "Gakudo Hoiku", please make sure to apply on time. If you miss the application deadline without any special reason, you may not be able to start using "Gakudo Hoiku" from April 1st, 2022.

Application forms will be available at each "Jidokan (children's house)" from October 25th, 2021 (Mon.).

Eligible Children:

Primary school children in the town (as of April 1st, 2022) whose parents

and other guardians are always away from home for work or other reasons are eligible. Available Days:

Monday to Saturday, except National Holidays and Year End/New Year Holidays that are closing of children's houses.

Monthly Fee:

¥3,000 (¥6,000 in August) for the 1st child.

¥1,500 (¥3,000 in August) for the 2nd child,

if two children in the same household use the "Gakudo Hoiku"

Free including August for the 3rd child or more children,

if more than two children in the same household use "Gakudo Hoiku"

How to apply:

Fill out the application form and submit it along with required documents directly

to a children's house where is in the school district of the school that your child attend.

with Infection Prevention Measures [大泉町感染症対策事業継続支援金] >>

In order to support businesses in the town that have been affected by a decrease in sales due to requests to shorten business hours or refrain from going out based on measures for the state of emergency or priority measures to prevent the spread of COVID-19, a support fund is provided to businesses in the town that have been determined to receive the government's "Getsuji Shienkin (Monthly support fund)" or the "Gunma-ken Kansensho Taisaku Jigyo Keizoku Shienkin (Gunma prefectural government's support fund for the business continuation with infection prevention measures)". Please note that businesses that are subject to the cooperation money for shortening business hours of restaurants are not eligible for this program.

Eligibility:

Businesses to meet all of the following conditions are eligible.

- To have been determined to receive the government's "Getsuji Shienkin (Monthly support fund)" or the "Gunma ken Kansensho Taisaku Jigyo Keizoku Shienkin (Gunma prefectural government's support fund for the business continuation with infection prevention measures)"
- To have business sites (shops, stores, etc.) in the town and be currently operating the business.
- · Individuals or corporations whose registered head office is located in the town.
- Support Fund: ¥30,000 (Only one time per eligible)
- Required document:
 - Application form

In order to prevent the spread of COVID-19, the town provides a support money to small and medium-sized businesses that take infection prevention measures such as disinfection, sterilization, and others at their business sites in the town.

Eligibility:

- Small and medium-sized businesses that meet all of the following conditions are eligible.
- To have business sites (shops, stores, etc.) in the town and be currently operating the business.
- To take infection prevention measures such as disinfection, sterilization, and others at their business sites in the town.
- · Not to be a Boryokudan member (a member of a crime syndicate) or not to have a socially reprehensible relationship with a Boryokudan member (a member of a crime syndicate).
- Support Fund: ¥20,000 (Only one time per eligible)

In order to support businesses in the town that are implementing infection prevention measures against COVID-19, the town provides an incentive to businesses that operate stores that have received "Stop COVID-19! Safe Business Certificate" implemented by Gunma Prefecture.

Eligibility:

Small and medium-sized businesses that meet all of the following conditions are eligible.

- To have been approved "Stop COVID-19! Safe Business Certificate" system implemented by Gunma Prefecture and also be willing to continue infection prevention measures based on this system.
- To have business sites (shops, stores, etc.) in the town and be currently operating the business.
- Incentive: ¥20,000 (Only one time per eligible)
- Required document:
 - · Application form
 - A copy of "Stop COVID-19! Safe Business Certificate" issued by Gunma Prefecture
 - A copy of the applicant's bankbook or cash card showing the bank account for the bank transfer





Old standard fire extinguishers need to be replaced. [旧規格消火器は交換が必要です]

Old standard fire extinguishers (extinguishers with the mark of applicable fire indicated by letters) installed in accordance with the Fire Service Act need to be replaced by December 31st this year. In buildings, etc., where the installation of fire extinguishers is required under the Fire Service Act, fire extinguishers whose models have expired due to the revision of the Ministerial Ordinance on Standards on January 1st, 2011 can continue to be installed until December 31st this year. However, after January 1st, 2022, the installation of fire extinguishers with expired models will not be allowed and will be in violation of the law, so please replace and recycle them systematically.

Fire extinguishers manufactured after 2012 are not old standard fire extinguishers. For fire extinguishers manufactured before 2011, please check the marks showing on the right. \times For fire extinguisher replacement, please consult your local fire equipment supplier.

Fee:

 - Please bring the small animal to be cremated in a cardboard box or etc.
 - Do not put any items in that may cause damage to the crematorium.
 - In some cases, such as large dogs, cremation may not possible.

- who have been certified as having a nursing care level 4 or 5.
