Diphtheria Tetanus Combined 2nd term: Those who were born from April 2nd, 2009 to April 1st, 2010 are eligible.

**Elderly Person Streptococcus Pneumoniae**: Those who were born during following periods are eligible.

# Additional 3rd Vaccination against COVID-19 [新型コロナワクチン追加接種(3回目)について]

The 3rd dose of COVID-19 vaccination has already started for healthcare workers, and we plan to send out vaccination coupons sequentially to the elderly who are 65 years old or older and people who are less than 65 years old for vaccination.

Inoculation Target: One dose will be given to those who are approximately 8 months or more from the completion of the 2nd dose.
 Inoculation Start: End of January, 2022

### Delivery of Vaccination Coupon:

Vaccination coupons will be sent out to those who have received their 2nd dose of vaccination by early July 2021.

(Vaccination coupons will be sent out sequentially to those who have received their 2nd dose of vaccination after early July 2021.) ■ Inoculation Place: In principle, the 3rd dose will be administered at the same place as the 2nd dose of vaccination.

- For those who are 65 years old or older and have received their 2nd dose of group vaccination at Bunka-Mura, Hachiya Hospital, or Tomo Vaccination Center, you will be notified of the date, time, and location (Bunka-Mura) of your 3rd dose of group vaccination. (You do not need to make an appointment by yourself.)
- Those who received the 2nd dose at their place of work, their family doctor's medical institution, an facility, or etc. need to make an appointment at the same place as the 2nd dose. If it is difficult to get an appointment due to the closure of the 2nd vaccination site, please contact the Health Promotion Division (*Kenko-Zukuri-ka*) as soon as possible.

#### ■ Vaccine to be inoculated:

The vaccine to be inoculated will be determined by the town based on the vaccine distribution status from the national government. For the 3rd vaccination, it is possible to use a different vaccine from the 2nd one, so we ask for your understanding and cooperation.

#### Notes for Vaccination:

- · Please wear clothes that allow you to show your shoulders.
- Please fill out the "Preliminary Examination Form (*Yoshin-Hyo*)" at your home in advance.
- Please be sure to come to the designated vaccination venue at the designated reception time. (The waiting area is limited. So even if you arrive earlier, you may not be able to wait inside.)
- If you need a wheelchair at the vaccination site, please contact the call center at 20276-55-4661 at least one day before the vaccination date.

# Disaster Prevention and Crime Prevention Information Notification System [防災・防犯などに関する情報を発信しています]

#### [Disaster Prevention Administrative Radio]

The town quickly informs residents of emergency information such as natural disasters and evacuation information. In case of emergencies such as earthquake early warning (seismic intensity of 4 or higher) or armed attack from other country, emergency information issued by the national government may be broadcast either early in the morning or at night.

#### Broadcast Contents:

- · Disaster information, Evacuation information
- · J-Alert information: Earthquake early warning, Special weather warning, Armed attack from other country, etc.
- · Administrative information from the town
- Other emergency information: Serious crime, etc.
- Regular time broadcast: The chime is broadcast daily at 5:00 PM as a test broadcast.
- Confirmation of broadcast content:

    - % If you are unable to connect to the above number, another phone number 0276-61-0500 is available for a charge.

# Coercive Collection Disposition of Town Tax Delinquency [町税等の滞納処分を実施しています]

The town taxes are used as a financial resource for various projects conducted by the town so that all town residents can lead healthy and affluent lives. When some people fail to pay their taxes on time, it is not fair to those who have paid on time, it puts pressure on the town's finances and has a great impact on the services provided to the town's residents. The town instructs delinquent taxpayers to pay their taxes by sending "*Tokusokujo* (reminders)" and "*Saikokusho* (demand letters)", making phone calls, and visiting them at home, etc. However, for those who do not pay their taxes even though they have the funds to do so, the following "*Taino Shobun* (delinquent payment measures)" are implemented.

Incidentally, the Tax Collection Division (*Shuno-ka*) of the town hall is always open for tax payment consultations. if you find it is difficult to pay your taxes by the deadline due to various reasons, please contact us as soon as possible.

In addition, please use safe and convenient account transfer method to pay your town taxes.

Examples of "Taino Shobun (Delinquent tax collection and disposition)":

- Those who have employee income: Make a payroll inquiry to their employer and seize their salary.
- $\cdot$  Those who own real estate, cars, etc.: Seize them and hold public auction.
- Those who own savings and other assets: Seizure of property when property is discovered during a financial institution's investigation

#### Points to note:

· For those who are delinquent in paying the town tax, a property survey will be conducted.

• There will be no prior notice before delinquent taxes are collected or disposed of.

· It costs a lot of money to collect or dispose delinquent taxes.

# File Tax Return from Home with Individual Number Card and Smartphone [マイナンバーカードを使って自宅からスマートフォンで確定申告]

It is convenient to file your income tax return at home using your individual number card (My Number Card) via e-Tax or smart phone. If you have your individual number card (My Number Card) and smartphone (with Individual Number Card reading function), you can file your income tax return at the "*Kakutei Shinkoku tou Sakusei* Corner (Tax Return Preparation Corner)" on the National Tax Agency website (https://www.keisan.nta.go.jp) without coming to income tax return consultation venues. So, please be sure to use this service from the viewpoint of infection prevention.

Advantages e-Tax and smartphone tax filing:

- At any time, you can file your tax return with your individual number card (My Number Card) and smartphone.
- · Just follow the on-screen instructions and the calculation will be done automatically.
- Past tax return data can be used for automatic input.
- · Chatbots or phone consultations are also available.
- In case of a tax refund, you can get an early refund with e-Tax.
- The data on the withholding tax slip is automatically entered by the smartphone's camera. (Scheduled for early January, 2022)

### Commencement of Cashless Payment Operation [キャッシュレス決済がはじまります]

From January 13th, 2022 (Thu.), cashless payment by credit card, electronic money, or QR code will be available for issuance fees of various certificates and other documents handled by the Resident Affairs Division (*Jumin-ka*). There is no need to take out cash, so please take advantage of this service.
