For Safe and Secure Trash Collection [安全安心なごみ収集にご協力ください]


All over the country, fires caused by batteries, mobile batteries, and lighters, and explosions caused by cassette cylinders and spray cans, have occurred during trash collection. In the event of a fire or explosion, the trash trucks would be scrapped and the trash collection workers would be in mortal danger.

The town collects batteries, mobile batteries, lighters, cassette cylinders, and spray cans, which can cause fires and explosions, as "hazardous trash" in orange containers on the collection day of recyclable trash.

When you dispose of your trash, please double-check the garbage collection calendar or trash sorting app. to make sure there are no error.

In addition to trash reduction and resource recycling, please cooperate in safe and secure trash collection by thoroughly separating trash so that collection workers are not exposed to danger.

Extraordinary Special Benefits for Resident Tax Exempt Households, etc.

[住民税非課税世帯等に対する臨時特別給付金を給付します]

As part of new economic measures against the impact of COVID-19, extraordinary special benefits will be provided to households exempt from per capita resident tax in fiscal year 2021 and households whose household income has suddenly changed due to the impact of COVID-19 after January 2021.

- Eligibility: Households that fall into either of the following categories are eligible.
 - ① Households in which all members of the household are exempt from the per capita resident tax in fiscal year 2021.
 - ② Households whose income has decreased since January 2021 and whose income is equivalent to exemption from resident tax.
- How to Apply:
 - ① Households exempt from resident tax will receive a confirmation letter from the town. When you receive it, please confirm the contents and return it after checking required items. The deadline for applications is April 18th, 2022 (Mon.)
 - ② Households whose income has decreased need to apply for the benefits. Please fill out the application form and submit it with required documents to the counter of "*Rinji Tokubetsu Kyufukin Call Center* (Extraordinary Special Benefits Call Center)" directly or by mail [Address: 〒370-0523 2465 Yoshida Oizumi-machi].
 - The deadline for applications is September 30th, 2022 (Fri.)

Application forms are available at the Welfare Division (Fukushi-ka) counter or can be download form the town hall website.

- Amount of Benefit: ¥100,000 per household
- Timing of Payment:

The payment will be transferred to the desired account in <u>approximately 2 weeks</u> after the confirmation or application form is reviewed and the benefits is decided.

For those who are eligible for "Extraordinary Special Benefits for Child-Rearing Households"

in FY2021 [令和3年度子育て世帯への臨時特別給付金対象の皆さんへ]

As a livelihood support program for child-rearing households affected by COVID-19, benefits are being provided to households raising children between the ages of 0 and 18 years. For those who were able to receive "Jido-Teate (Child Allowance)" for September 2021, the money was transferred to the child allowance receiving account on December 17th, 2021.

If you need to apply for the benefits, such as raising only high school students or etc., and have not yet done so, please remember to submit your application by the deadline of March 11th, 2022 (Fri.)

Please note that the application deadline is different for newborns born after February 2022.

- Eligible Children: Children who were born between April 2nd, 2003 and March 31st, 2022
- Eligible Recipients:

Parents or guardians of the eligible children receiving "Jido-Teate (Child Allowance)" except for the "Tokurei-Kyufu (Special Benefit **), or those with equivalent income (of the guardians, the one who has a higher degree of livelihood).

X Special benefit recipients are those whose income in 2020 is above the income limit of the child allowance and who receive a flat monthly allowance of ¥5,000 per child.

- Payment: ¥100,000 per eligible child
- How to Apply:

Application forms were mailed to those eligible on December 27th, 2021. Please fill out necessary information in the form, and submit it to the Children Affairs Division (*Kodomo-ka*) at the 23rd counter on the 3rd floor of the town hall.

The above benefits are being provided to those who received "*Jido-Teate* (Child Allowance)" in September 2021 (for those who are raising only high school students, those who are raising eligible children as of September 30th, 2021).

Town-owned Housing for Rent [町営住宅入居者募集]

The town is looking for tenants for town-owned housing "Yoshida-Kita Choei Jyutaku." If there are too many applicants, tenants will be selected by a lottery.

- Housing Type: 3DK (3 Bed Rooms) for standard households
- Number of units offered: 1 unit
- Eligibility: Households of 2 or more people who live or work in the town and have paid their municipal taxes in full are eligible.
- Monthly Rent Fee: ¥25,700 ~ ¥50,500 (Determined by income of the household)
- Usage fee for common facilities: ¥1,000 per month
- Parking lot fee: ¥2,000 per month (Only one parking lot per household is available.)
- Security deposit: 3 months of the housing rent fee
- How to apply:

Do NOT Pour Foreign Objects or Oil into the Sewer System [下水道に異物・油を流さないでください]

< Foreign Objects >

If foreign materials are spilled into the sewer system, they may damage the equipment of the sewer treatment facility.

Please do not flush towels and underwear down the toilet (only water soluble toilet paper, etc. can be flushed.), and use a drainage to prevent hair and food debris from flowing down the drain.

< 0il >

When oil flows into the sewer system, it solidifies in the sewer pipes and causes a foul odor. In addition, water purification centers downstream may not be able to treat it due to the increased oil content in the sewage.

- How to dispose of oil at home:
 - · Transfer the remaining oil to a special oil strainer while it is still hot, and use it for stir-fly or other cooking.
 - · Wipe off as much oil as possible from pots and dishes before washing.
 - · Old oil should be absorbed with old newspapers or hardened with a special oil hardener and disposed of as burnable trash.
 - · Leftover oil is collected by the Environmental Development Division (*Kankyo Seibi-ka*) at the 5th counter on the 1st floor of the town hall. Please put it in a plastic bottle and bring it directly to us.
- Requests to Restaurants and Food Shops that use a lot of oil

Please manage the oil trap appropriately.

- Clean the basket. (Once everyday)
- Remove grease and oil that cause bad odor. (At least once a week)
- Remove garbage or other waste materials. (At least once a month)
- Clean the inside of the oil trap (At least once every 2-3 months)

Prepayment System for National Pension Insurance Premium [国民年金保険料 前納制度]

If you use the prepayment system for National Pension Insurance Premiums, you will receive a discount on premiums according to the prepayment period.

■ Prepayment by cash (Payment Slip):

Payment slips for prepayment for one fiscal year and six months will be sent out from the Japan Pension Service in early April. If you wish to prepay for two years, you need to apply.

In addition, you can prepay for any month up to the end of the current or next fiscal year.

Prepayment by account Transfer or credit card:

If you would like to apply, please submit an application form to the Resident Affairs Division (*Jumin-ka*) or Ota National Pension Office.

If you wish to make a 2-year, 1-years, 6-month prepayment (April ~ September), please apply by the end of February. For details, please contact Ota National Pension Office at 20276-49-3716 or the Resident Affairs Division (*Jyumin-ka*) at 20276-63-3111 (ext.534).

Lottery sale of recycled goods [再生品の抽選販売会]
