Provides Financial Support for Children of Single-Mother and Single-Father Families to Enter School or to Advance to Higher Education [母子・父子家庭などの入学・進学支度金を支給します]

The town provides financial support for single-mother and single-father families whose children go on to higher education, such as high school, technical college, or vocational school, in this fiscal year. Families whose children have entered primary school or advanced to junior high school and have not applied for this program by the end of March will be accepted at the same time.

- Eligible Persons: Those who meet the following conditions who have become a single-mother or single-father family due to the death of a spouse or divorce, or who are raising a child without a parent.
 - Residents of the town who raise a child and live with the child.
 - Those who are exempt from income tax for 2020.
 - Those who are not receiving public assistance.
- Amount Paid:
 - For High School: ¥20,000
 - For Junior High School: ¥15,000
 - For Primary School: ¥10,000
- How to Apply: Fill out necessary information in the application form, and apply it with required documents directly to the Children Affairs Division (Kodomo-ka) at the 24rd counter on the 3rd floor of the town hall.
- Deadline of Application: May 27th, 2022 (Fri.) except Saturdays, Sundays, and National Holidays.



Information from Taxation Division [税務課からのお知らせ]

Municipal taxes are divided into ordinary taxes and earmarked taxes. The ordinary taxes are used for a variety of projects, and the earmarked taxes are used for special purposes.

[Ordinary Taxes]

Resident Tax (Individual):

- · Individuals who have a domicile in the town as of January 1st of the relevant year and had income in the previous year are taxed.
- · Individuals who have a office, a business establishment, and real estate in the town even though they do not have a domicile in the town as of January 1st of the relevant year are also taxed.

Resident Tax (Corporate): Corporations that have a office, a business establishment, a dormitory, and etc. are taxed.

Property Tax: Those who own property in the town as of January 1st of the relevant year are taxed.

Light Vehicle Tax: Those who own light motor vehicles and etc. as of April 1st of the relevant year are taxed.

Tobacco Tax: This tax is included in the price of cigarettes sold in town.

[Earmarked Taxes]

City Planning Tax: This tax is used for the city planning projects such as roads, sewers, parks, and so on, and is levied on owners of land and houses located in urbanized areas as of January 1st of the relevant year.

National Health Insurance Tax: This is a tax that people support each other so that people can receive medical treatments without anxiety. The tax is levied by the head of the household with the insured person.

< Reduction and Exemption System for the Disabled >
 If light motor vehicles owned by a physically disabled person
 meet certain conditions, the light vehicle tax on the vehicle will be
 exempted by application. Since application every year is required,
 please apply for it by May 31st (Tue.) after receiving the tax notice.

You can pay the tax by credit cards via the web-site "F-REGI *Kokin-Shiharai*", or you can also use the smartphone apps (LINE Pay & PayPay) to pay the tax.

 - ·Don't buy extra food. ·Peel vegetables and fruits thinly. ·If you overcook a dish, freeze or remake it.
- Points to consider for disposal of food products
 - Drain thoroughly and dispose of in burnable trash. Bury directly in fields, etc. Use a composter or electric garbage disposal.
- * The town subsidizes the purchase of composters and electric garbage disposals for the purpose of reducing food waste and composting as a measure against food loss.

Rabies Vaccination in Spring [春の狂犬病予防注射]

Spring Rabies Vaccinations (group shots) for FY2022 will be administered by the town. According to the Rabies Prevention Law, the registration of dogs aged 91 days old or more is required once in their life, and the rabies vaccination once a year is also required. If you own dogs, please be sure to register your dogs and have them vaccinated without fail.

- Registration: Once in a dog's lifetime
- Frequency of Rabies Vaccination: Once a Year
- Date, Time, and Location: 9:30 11:30 on May 14th, 2022 (Sat.) at North Parking Lot of the town hall
 - X Animal hospitals belonging to Gunma Veterinary Medical Association are also doing the registration and the vaccination. If the vaccination was not given during the period of the group shot, please take it at a animal hospital. Please check with your animal hospital for the fees, as they may differ.
- Fee: ¥3,500 per registered dog for the vaccination only. ¥6,500 per dog for the registration and the vaccination.
- Note: Please be sure to notify the Environmental Development Division (*Kankyo-Seibi-ka*) at the 5th counter on the 1st floor of the town hall of any changes in the registration information such as the death of your dog or a change in the owner.

< Clean up dog's droppings! >

Many people are annoyed by dog's owners who were leaving droppings on riverbeds, sidewalks, rice paddy roads, and etc. You, the owner, must clean up your dog's droppings when you walk your dog. Dog waste should be buried in your yard or disposed of as "Burnable Trash" in small amounts in plastic bags to prevent the contents from flying around.
